NPSC EXECUTIVE TEAM (2025-27)

The meeting of the General Body of the National Progressive Schools' Conference was convened on <u>Friday</u>, <u>26 Sep</u>, <u>2025 at 02:30 p.m</u>. The election for the new office bearers of NPSC for the term 2025–2027 were held in accordance with the provisions of the Rules and Bye-laws of the Society.

In pursuance of the Bye-laws of NPSC, a three-member Returning Committee was duly constituted to conduct the election proceedings. Initially, Mr. S.L. Jain was nominated as the Returning Officer; however, due to health reasons, he expressed his inability to undertake the responsibility.

Accordingly, the Chairperson proposed the name of Dr. Usha Ram, Life Member, NPSC, as the Returning Officer in the Executive Body meeting dated 18 August, wherein it was unanimously approved by the members present.
