Sub.: Amendment in Affiliation Bye-Laws of the Board –reg.

Consequent upon the recommendations of Affiliation Committee made at its meetings held on 13.12.2016 and ratified by the Governing Body in its meeting held on 20.12.2016, the following amendments in Affiliation Bye-Laws of the Board have been made:-

<p>Notwithstanding anything contained in these rules or otherwise every employee including Head of Institution shall retire from service on attaining the age of 60. However if the age of superannuation falls during the academic session, the concerned employee will retire at the end of the academic session.</p> <p>Provided further that if such employee is recipient of National/State/CBSE Teachers' Award, he/she shall superannuate from service on attaining the age of 65 subjected to meritorious service, good health and good conduct".</p>	<p>"Notwithstanding anything contained in these rules or otherwise every employee including Head of Institution shall retire from service on attaining the age of 60 years. However, if the age of superannuation falls during the academic session, the concerned employee including Head of Institution will retire at the end of the academic session.</p> <p>Provided, if such employee including Head of Institution is a recipient of National Award only, he/she may be considered for a further extension of service for two years after attaining the age of superannuation subject to meritorious service, impeccable character, sound health, good leadership, management qualities and outstanding results throughout.</p> <p>The school managing committee after considering such exceptionally meritorious cases of extension of service, shall forward the details to the Board for prior approval. Further, no extension shall be given without prior approval of the Board.</p>

Further no extension shall be given without prior approval of the Board.
